RESOLUTION ADOPTING FOR IMPLEMENTATION THE UNIFIED PARK PROTECTION PLAN OF MOUNT MALINDANG RANGE NATURAL PARK FOR CALENDAR YEAR 2005.

WHEREAS, presented for consideration is the Unified Park Protection Plan of Mount Malindang Range Natural Park for CY 2005, which aims to conserve the biological diversity and maintain or improve the life-support services of Park through the active participation of the Local Government Units and other stakeholders;

WHEREAS, this Body, after thorough deliberation, finds the plan appropriate for implementation because the gigantic and difficult task of protecting the park against various forms of manmade destruction need the active support and participation of the Local Government Units and other stakeholders due to the apparent lack of resources of the Department of Environment and Natural Resources (DENR) in the province.

NOW THEREFORE, on joint sponsorship, it was





RESOLUTION EARNESTLY REQUESTING ALL LOCAL GOVERNMENT UNITS OF MISAMIS OCCIDENTAL AND OTHER CONCERNED AGENCIES FOR THE ADOPTION AND IMPLEMENTATION OF THE UNIFIED PARK PROTECTION PLAN FOR CY 2005 OF MT. MALINDANG RANGE NATURAL PARK

WHEREAS, the catastrophe that happened in the provinces of Aurora and Quezon last November 29, 2004 have once again reminded us that the result of forest degradation is very costly in terms of value of properties damaged, the irrecoverable lives lost and the huge amount needed for relief operations and repair of damages;

WHEREAS, to avoid the occurrence of environment or forest related catastrophes in our province, the remaining 34,000 hectares of forest in Mt. Malindang Range Natural Park must be effectively protected against clandestine cutting of timber and other destructive human activities because it is the sole provider of potable water and other life-support services for all inhabitants of Misamis Occidental and the eastern parts of Zamboanga del Norte and Sur;

WHEREAS, due to the limited resources of the DENR for the effective protection of Mt. Malindang Range Natural Park, there is an urgent need for other major stakeholders like the Local Government Units in Misamis Occidental which have the primary obligation to protect the welfare by law (Local Government Code of 1991) to help the DENR protect the environment particularly the watershed areas;

WHEREAS, to facilitate the active participation of the DENR and the various Local Government Units of the province in the protection of the said natural park, the Protected Area Superintendent has prepared a unified park protection plan for CY 2005;

WHEREAS, this body has found the said unified park protection plan in order;


NOW THEREFORE

Foregoing premises considered, this body, on joint sponsorship, seeks to resolve as it hereby **RESOLVES** to strongly recommend to the Government Officials concerned the approval and immediate implementation of the Unified Park Protection Plan for CY 2005 of Mt. Malindang Range Natural Park.




