MMNP-PAMB Resolution No. 98-03

RESOLUTION SETTING THE LOCATION OF THE SITE OF THE PROTECTED AREA OFFICE FOR THE MT. MALINDANG NATURAL PARK.

WHEREAS the construction of the Protected Area Office for Mt. Malindang Natural Park has been delayed due to failure to identify the appropriate site for the said office;

WHEREAS this body believes that constructing a P.A. Office inside Mt. Malindang the protected area is not practical and almost inaccessible to the general public due to the distance of the site from the provincial highway where all roads emanate, lack of regular transportation facilities from the urban areas to the P.A. site, poor condition of roads from urban communities to the P.A. site, and the terrain of the area which cannot allow construction of access road along the boundary of the P.A. that will connect the P.A. Office to other communities within the province;


WHEREAS due to the uncertain peace and order condition in the remote areas, constructing a P.A. Office in the site would be too risky in terms of security for the P.A. Staff, Office equipments and facilities which might lead to unnecessary waste of money and effort when in times of trouble government buildings will be abandoned as what had happened in other sites;

WHEREFORE foregoing premises considered, this body, on motion of Timo-ay Ruben Da. Baliton duly seconded by Timo-ay Rodulfo Lingua, **RESOLVED** to have the P.A. Office constructed outside the protected area site preferably near or along the National or provincial highway which is accessible to the general public provided that 4 guardposts shall be constructed in strategic locations inside the P.A. where park rangers will stay.

RESOLVE finally to request PASu Rolando S. Dingal to negotiate the prospective donors of the site for P.A. Office and finalize the necessary documentations.



Malindang.
